

Legal requirement (Decree No. 87/2015. (IV. 9.) of the Hungarian Government:

One of the **prerequisites of launching new study programmes** in BA or MA is the existence of **mobility windows from 2019/20 academic year**

Rationale beyond the initiative

- Internationalisation highly ranked on HE agenda
- Ambitious mobility goals set outwards/inwards
- Increasing funds to support mobility and HEIs
- Modernisation of traditional curriculum
- Legal requirement is a stronger impetus



Practical aspects

- Saturation level reached? - increase of mobility...
- Diversifying mobility partnerships
- Capacity building at regional level
- Promote MWs at national and HEI level



Our general understanding of MWs

“period of time reserved for international student mobility that is **embedded** into the curriculum of a study programme”

'Curricular embeddedness' =

- The mobility period is an **explicit part of the home curriculum**, the study plan and the study programme.
- The home curriculum and study plan create **transparency about the possibility of recognising the stay abroad** (full recognition).



Regulatory framework for new programmes

„During the study programme mobility window is available for the purposes of credit mobility abroad”.

Offers flexible options for implementation in HEIs/Faculty/Dept. – suitable for all subjects

Tool for quality enhancement



Types of mobility windows

- *Optional and not regulated – very flexible*
- *Obligatory and regulated in content*
- *Obligatory, but not regulated in content*
- *Optional, but strictly regulated in content*

Aspects of accreditation – quality assessment

- Type of mobility window
 - Planned minimum and maximum duration is reasonable
 - Which semester, can it be well identified in the curricula?
 - Content of the mobility window
 - Recognition issues are tackled, well planned
 - Selection of partners abroad is clear, orientation is well defined
 - Prerequisites for the students?

Proposal for aspects to the accreditation committee

- MW requirement should contribute to the conceptual analysis of proposed programme, quality of teaching process
- No details should be required concerning partners, courses, teachers abroad etc.
- Structure of the curricula should be in line with the explanation of the proposed MW
